## 2. Online payment for HughesNet Broadband Services

- 1) User of this online payment system has to be a registered subscriber of HughesNet Broadband Services. The registered subscriber possesses a unique 9 digit identifier called SiteCode & also 7 numeric digit Subscriber ID issued by HughesNet Broadband Services.
- 2) The Subscriber may pay through any valid credit card
- 3) HCIL has a tie-up with ICICI bank for facilitation of this service and hence the transaction would be completed thru the ICICI payment gateway
- 4) HCIL & ICICI shall not do any validation in regard to the bonafide nature of the subscriber & shall simply collect th payment made through the card.
- 5) Subscriber can pay any amount as desired, keeping in mind the debit balance reflecting against the subscriber account, late fees etc. in HCIL Bpcare portal so that the subscriber connection does not get disconnected for short payments
- 6) HCIL has opted for 3D secure system of VISA / MASTER credit cards and hence the subscriber would be once more authenticated before the actual transaction takes place
- 7) The transaction charges as levied by the respective bank would be applicable as per the user agreement with the bank which has issued the credit card
- 8) Once the payment has been received by HughesNet Broadband Services, the receipt of the payment would be available to the subscriber vide an electronic mail from <a href="mailto:sme@hughes.in">sme@hughes.in</a> within 3 working days of confirmation of payment to HughesNet Broadband Services.

9) Up to date details of all subscriber payments would be available on the customer portal provided to our subscribers and the subscribers may check the status of their payments / accounts in the portal whenever they wish to.
